Capital Markets Day 2023

We arranged a Capital Markets Day on May 10, 2023, in Helsinki. At the event, we introduced our updated strategy and new financial targets. The day included presentations by Konecranes President and CEO Anders Svensson, CFO Teo Ottola, and Business Area Heads Fabio Fiorino and Mika Mahlberg. On the following day, we arranged a site visit to our Hyvinkää headquarters and factory. The visit included short presentations and a factory tour, as well as demos of Konecranes' crane technology and digital Service tools.

Roadshows and other events during the quarter

During the quarter, we organized roadshows in London with Carnegie, in Brussels and Frankfurt with SEB, as well as in Stockholm with Kepler Cheuvreux. In addition, we participated in Danske Bank's Large Cap seminar in Paris, held group investor meetings hosted by analysts and discussed with investors on many individual 1-1 calls and meetings.

During the quarter, the most frequent discussion topics have included: updated strategy and new financial targets presented at the CMD, market environment, demand outlook and financial guidance, sustainability, delivery capability and status of supply chains, cost inflation and pricing, and Group and segment margin development.
