# Q4 2021 Highlights

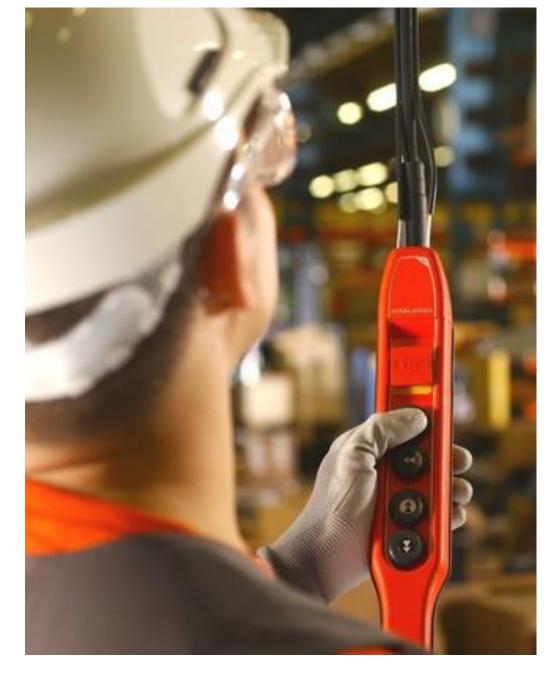
# 2021 ended on a strong note and all three Business Areas performed well

- The hard work to mitigate the impact of global component availability issues continued
- Group adj. EBITA-% at 11.9% in Q4 (10.9%), highest Q4 adjusted EBITA-% ever and beating previous record from last year
- Service Q4 adj. EBITA-% at all-time high of 21.0%, Industrial Equipment at 6.2% and Port Solutions at 8.5%

# Overall market sentiment continued stable and relatively similar to Q3, COVID-19 related market volatility is not over

- Q4 order intake grew 4.2% Y/Y in comparable FX, stabilization in short-cycle product orders after three strong quarters
- Component availability, customer delays and other supply chain constraints continued to affect Q4 sales
- Good sales execution maintained and late backlog prevented from growing from Q3 thanks to mitigating actions, Q4 sales increased 1.3% Y/Y
- With strong Q4 orders, order book broke again a new record of over EUR 2 billion at the end of December

New financial guidance for 2022, Q1 demand outlook updated EUR 0.88 dividend per share proposed for 2021



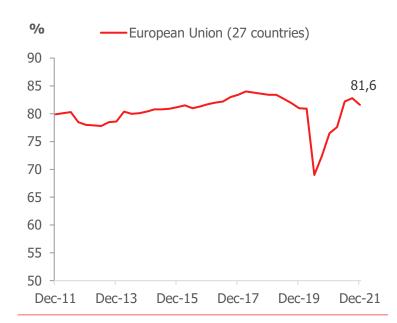

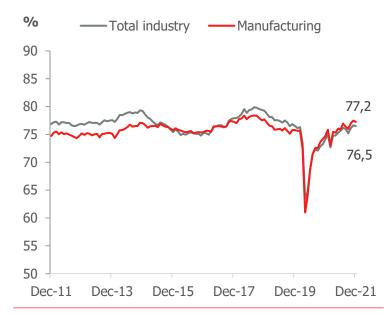
# Market environment – Service and Industrial Equipment

### Capacity utilization rate – EU



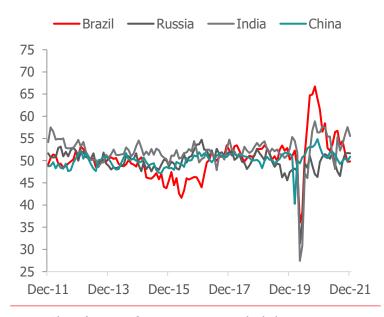
- In Europe, operating conditions continued to improve in Q4 despite the continued supply-side constraints, December's PMI was 58.0
- Manufacturing industry capacity utilization rate decreased in Q4 but remained slightly above the pre-COVID level

### Capacity utilization rate – USA



- In the US, the manufacturing sector's PMI reading was 57.7 in December although material shortages and supplier delays continued
- Manufacturing capacity utilization rate continued to trend further upwards in the end of 2021, but has not yet reached the recent peaks of mid-2018

### PMIs – BRIC countries

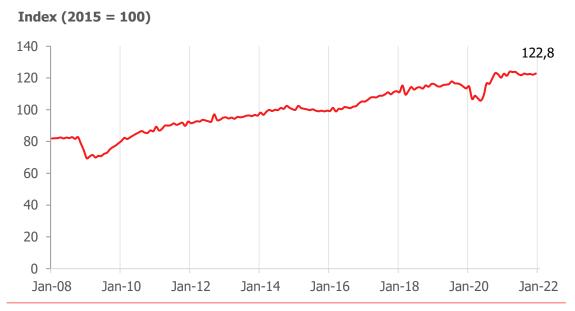


- China's Manufacturing PMI ended the year in improvement with a reading of 50.9
- In Brazil, the Manufacturing PMI was in deterioration at 49.8 in December
- In India, the Manufacturing PMI was firmly in expansion with a reading of 55.5 in December and in Russia, December's PMI was also in expansion at 51.6

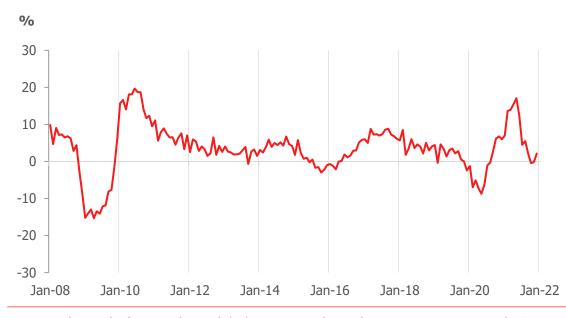
## Market environment – Port Solutions

### Monthly index change Y/Y



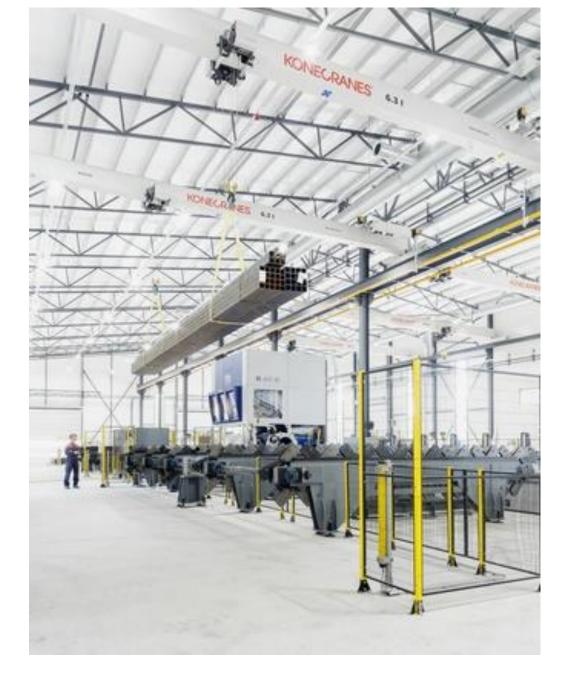
• At the end of December, global container throughput was approximately 2 percent higher than the year before

# Q1 Demand outlook

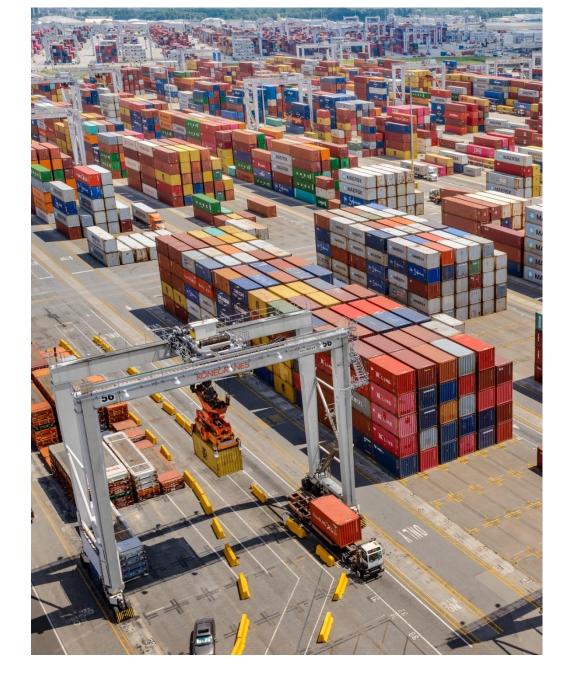
- The worldwide demand picture remains subject to volatility due to the COVID-19 pandemic.
- In Europe and North America, the demand environment within the industrial customer segments is on a healthy level. In Asia-Pacific, the demand environment remains below Europe and North America.
- Global container throughput continues to be at a record high, and long-term prospects related to global container handling remain good overall.

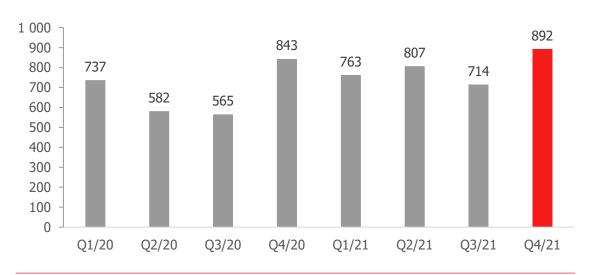

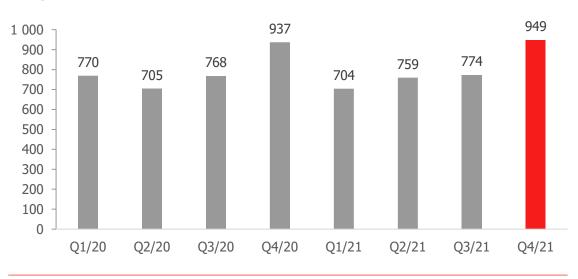
### **Group order intake, MEUR**



### Order intake increased of 5.8% to EUR 892.3 million (843.3), 4.2% on a comparable currency basis

- Orders received increased in the Americas and EMEA but decreased in APAC
- Orders received increased in Service (31.7%) and Industrial Equipment (13.8%) but decreased in Port Solutions (-12.1%)

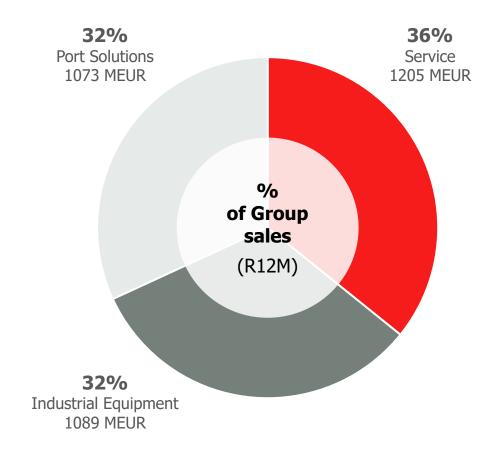
### **Group net sales, MEUR**



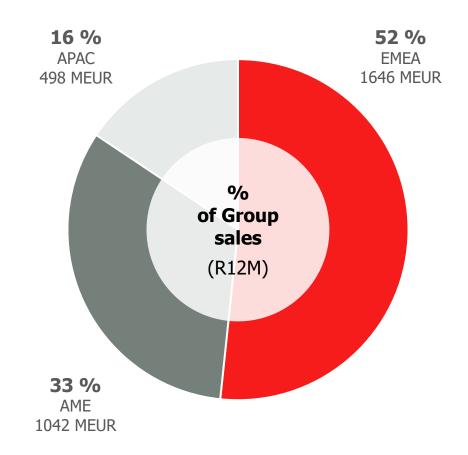
- Sales increased 1.3% to EUR 948.9 million (936.8), -0.4% on a comparable currency basis
- Sales increased in Service (5.4%) and Industrial Equipment (5.9%) but decreased in Port Solutions (-4.9%)

### Group sales by business area

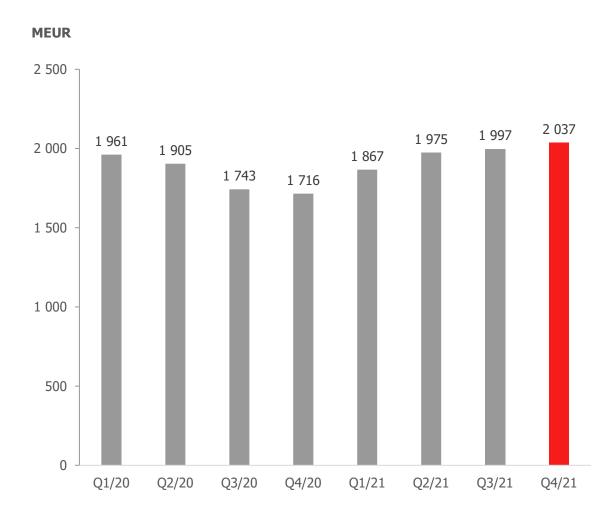


### Group sales by region



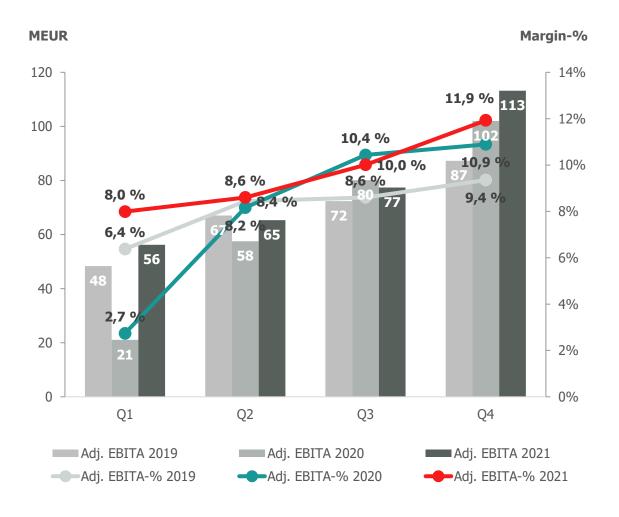


# Q4/21 Group order book



- The value of the order book increased 18.7% to EUR 2,036.8 million (1,715.5)
- On a comparable currency basis, the order book increased 15.7%
- Order book increased in Service (60.9%), Industrial Equipment (18.5%) and Port Solutions (8.9%)

# Q4/21 Group adjusted EBITA



- Group adjusted EBITA increased to EUR 113.2 million (102.1), 11.9% of sales (10.9)
- The increase in the Group adjusted EBITA margin was mainly driven by positive sales mix and continued focus on strategic initiatives
- Gross margin improved on a year-on-year basis

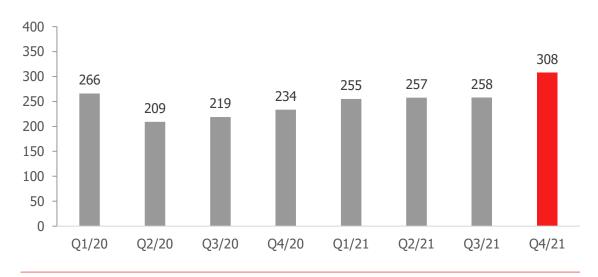






# Q4/21 Service order intake and agreement base value

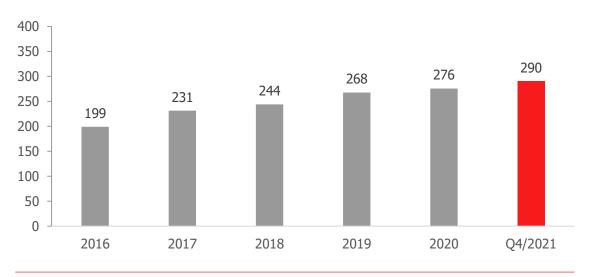
### Service order intake, MEUR



### Service orders received increased 31.7% to EUR 307.7 million (233.6). On a comparable currency basis, orders received increased 28.3% percent

- The year-on-year increase was positively impacted by a large order to modernize four polar reactor cranes in the United States
- Both field service orders and parts orders increased
- Order intake increased in the Americas and EMEA but decreased in APAC

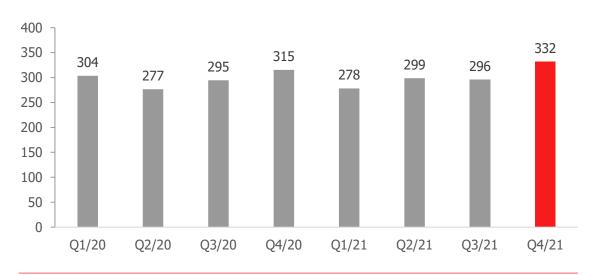
### Service agreement base value<sup>(1)</sup>, MEUR



- Year-on-year, the annual value of the agreement base increased 5.3% to EUR 290.4 million (275.7). On a comparable currency basis, the annual value of the agreement base increased 1.7%
- Sequentially, the annual value of the agreement base increased 1.3% on a reported basis and stayed approximately the same with a change of 0.0% on a comparable currency basis

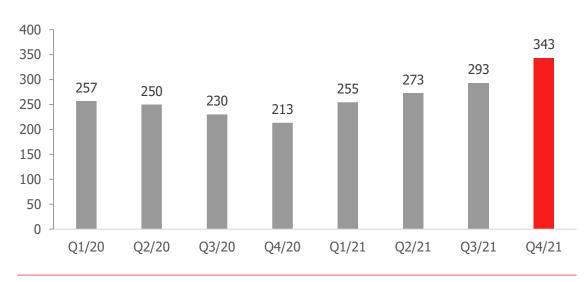
# Q4/21 Service sales and order book

### Service sales, MEUR



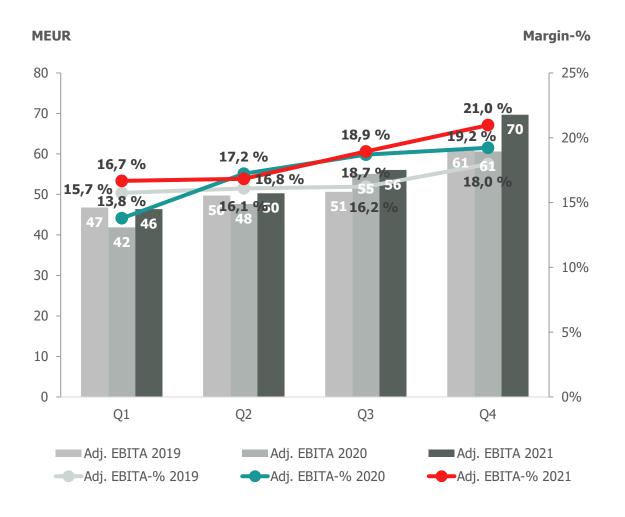
- Sales increased 5.4% to EUR 332.2 million (315.3)
- On a comparable currency basis, sales increased 2.7%
- Both field service sales and parts sales increased
- Sales increased in the Americas, EMEA and APAC

### Service order book, MEUR



- The order book increased 60.9% year-on-year to EUR 343.5 million (213.4)
- On a comparable currency basis, the order book increased 54.1%

# Q4/21 Service adjusted EBITA



- The adjusted EBITA was EUR 69.7 million (60.6) and the adjusted EBITA margin 21.0% (19.2)
- The increase in the adjusted EBITA margin was mainly attributable to sales growth and positive sales mix
- Gross margin improved on a year-on-year basis

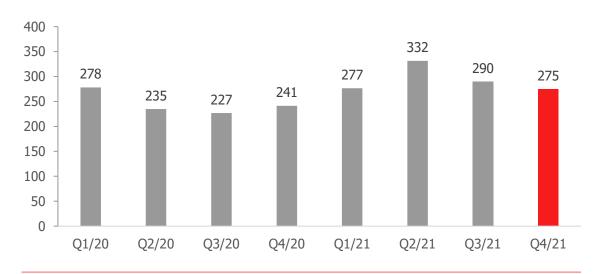

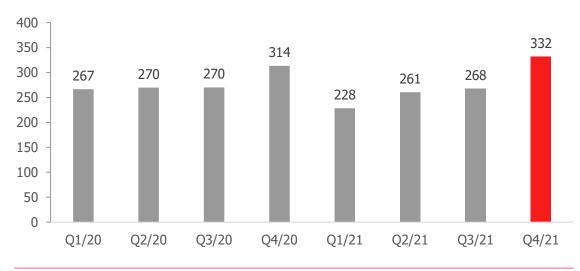
# Q4/21 Industrial Equipment order intake and sales

### **Industrial Equipment order intake, MEUR**



- Orders received totaled EUR 274.5 million (241.3), corresponding to an increase of 13.8%
- External orders received increased 11.8% on a reported basis and 9.3% on a comparable currency basis
- Order intake increased in standard cranes, process cranes and components
- Orders received increased in the Americas, EMEA and APAC

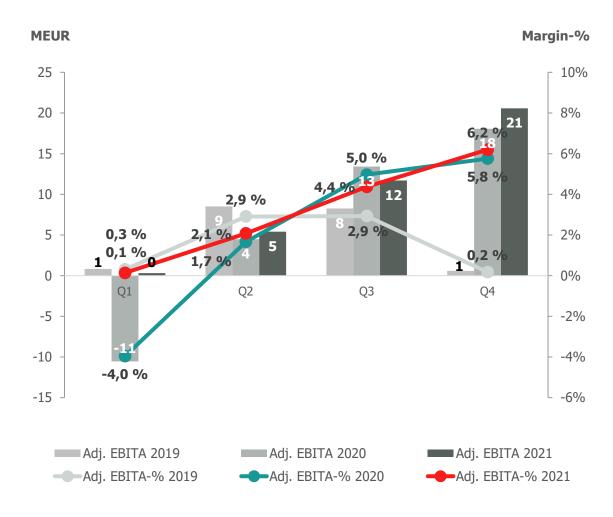
### **Industrial Equipment sales, MEUR**



- Sales increased 5.9% to EUR 332.1 million (313.6)
- External sales increased 5.4% on a reported basis and 3.2% on a comparable currency basis
- Sales increased in standard cranes and components but decreased in process cranes
- Sales increased in the Americas, EMEA and APAC

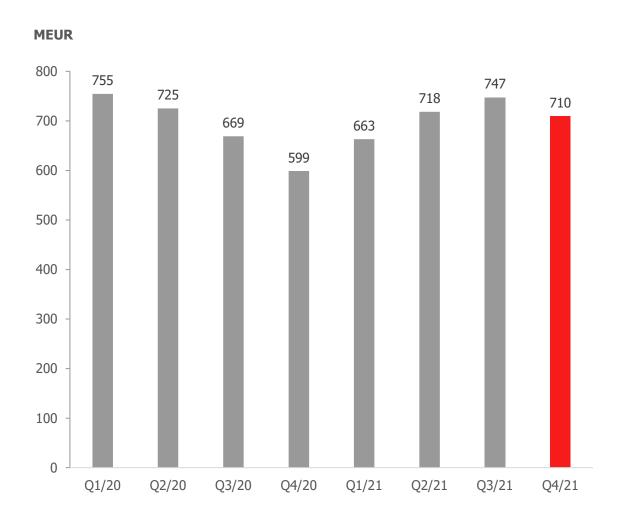


# Q4/21 Industrial Equipment adjusted EBITA



- The adjusted EBITA was EUR 20.6 million (18.1) and the adjusted EBITA margin 6.2% (5.8)
- The increase in the adjusted EBITA margin was mainly attributable to higher sales, continued progress on strategic initiatives and positive sales mix
- Gross margin improved on a year-on-year basis

# Q4/21 Industrial Equipment order book

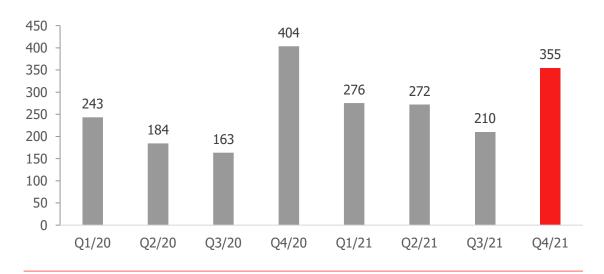


- The order book increased 18.5% year-onyear to EUR 709.9 million (598.8)
- On a comparable currency basis, the order book increased 12.6%

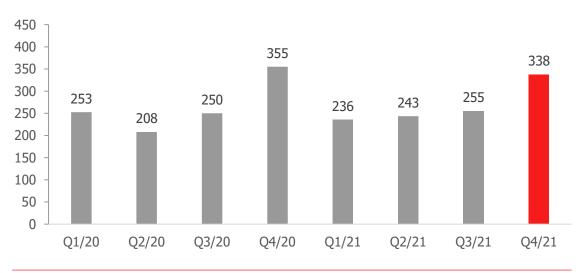
### Port Solutions order intake, MEUR



### Orders received totaled EUR 354.9 million (403.7), representing a decrease of 12.1%. On a comparable currency basis, orders received decreased 12.5%

Orders received decreased in the Americas and APAC but increased in EMEA

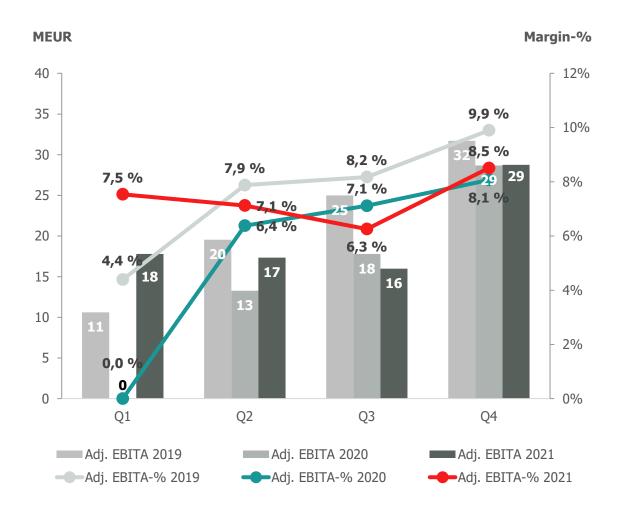
### **Port Solutions sales, MEUR**



 Sales decreased 4.9% to EUR 337.9 million (355.3). On a comparable currency basis, sales decreased 5.5%



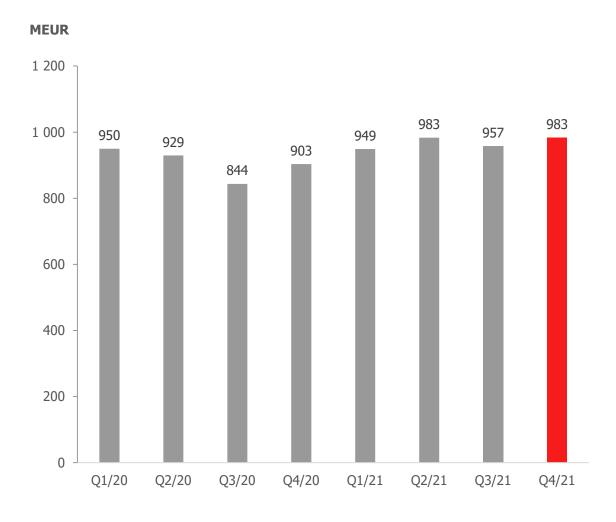
# Q4/21 Port Solutions adjusted EBITA



- The adjusted EBITA was EUR 28.8 million (28.7) and the adjusted EBITA margin 8.5% (8.1)
- The increase in the adjusted EBITA margin was mainly attributable to improved project management execution and positive sales mix
- Gross margin improved on a year-on-year basis



# Q4/21 Port Solutions order book

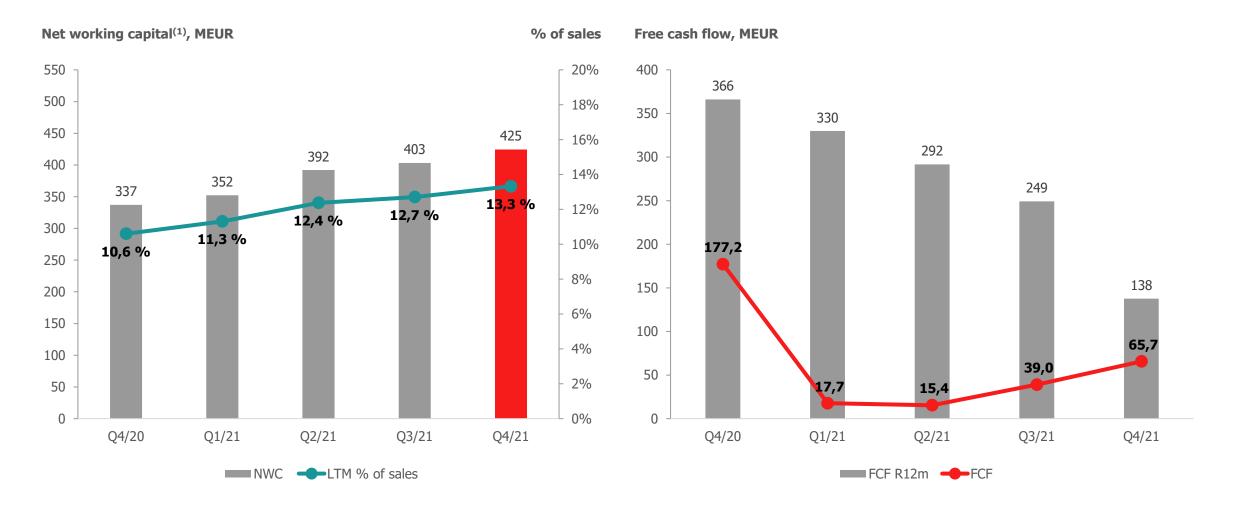


- The order book increased 8.9% year-on-year to EUR 983.5 million (903.2)
- On a comparable currency basis, the order book increased 8.4%

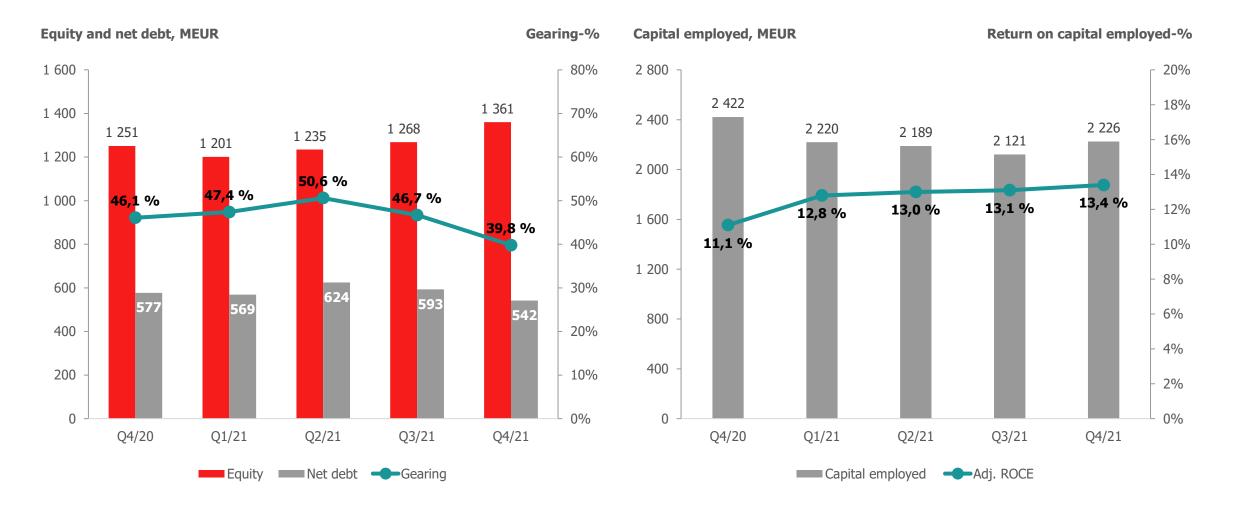




# Net working capital and free cash flow

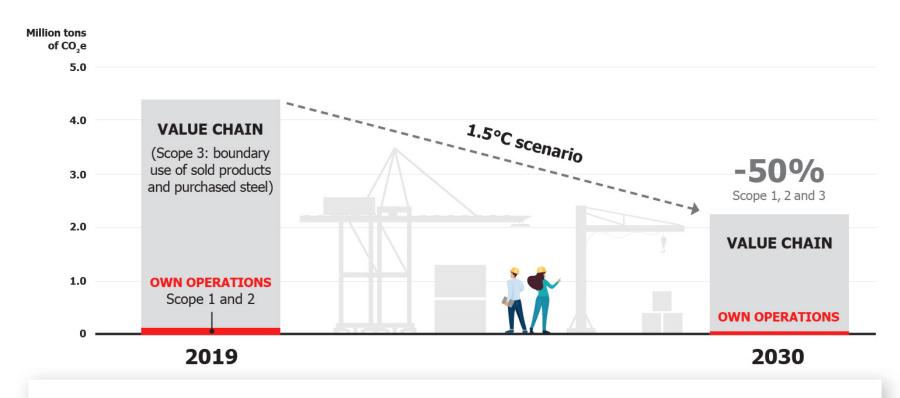
